INTRODUCTION



Comprehensive analytics, social collaboration and mobile features enhance insights and promote teamwork, enabling organisations to accurately sense, predict, and shape demand.

Beyond enabling this core Demand Management capability, **the Solution Set provides a platform for growth**, not only allowing expansion of capabilities to include Supply Planning, but ultimately Sales & Operations Planning also.

SOLUTION SET SCOPE

The core offering of the solution set includes the setup of the Unified Data Model on which all the Supply Chain Planning (SCP) components sit as well as delivering the Demand Management functionality of the SCP stack shown in the below diagram. Optionally the other SCP components, Supply Planning and S&OP, can also be included within the same project implementation if desired:

The solution set will provide everything from bringing multiple demand signals together to help the user better understand demand for products, channels, and segments, which will allow the demand planner to better anticipate customer needs.

With Demand Management's built-in analytics capability, you can reveal demand patterns, analyze demand signals and identify changes in real time, so the user can respond quickly to change and react appropriately. The system can use bookings or shipments to forecast customer demand, to improve demand sensing and to calculate forecast accuracy.

Using a combination of built-in planning algorithms with historic-based Demand we can accurately predict product forecast through the generation of statistical forecasts. This can be further enhanced by incorporating cause-and-effect correlation of demand, to external and internal influencing factors with business knowledge, to create a final Demand Forecast. Demand Management's forecasting engine can be used to automatically detect demand patterns, trends, seasonality, and intermittence for every demand signal.

The engine cleanses historical demand signals, such as shipments and bookings, to detect outliers, and fills in missing data to minimize forecast error. The hierarchy level at which the forecast is required by the customer can be configured. Furthermore, the forecasting engine can predetermine the hierarchy levels where the forecast is statistically significant and can blend different forecast models to produce a more reliable statistical forecast. Forecast is regenerated for each product and location during every planning cycle and proactively adjusts to changing market conditions.

Once the Demand plan has been created it can be reviewed and approved in system ahead of being used further down the Supply Chain.

SOLUTION SET TIMELINE

The accelerated implementation timeline of 14 weeks will follow the phases and include the key activities outlined below, the accelerated timeline approach can also be adjusted to include an additional Play Back activity or optional components should that be desired:

Business Adoption Services:

 - to support the customer to set up for success.


Other Optional Services:






PROJECT DELIVERY APPROACH
